

Fife Landscape Review – survey representations

As part of the landscape review, an open invitation was made to participate in the review by submitting views on landscape quality. The purpose of community engagement has been to complement the independent technical assessment. The results of the community engagement are taken into account in the evaluation, but do not form the basis for determining recommendations on landscape designations. The public will have further opportunity to comment on the recommendations once the draft Local Plans are published for consultation.

Information was gathered on public attitudes to landscape through the creation of an online survey. The purpose of the survey was:

- To gather community views on the local landscapes to identify which landscapes local people felt were important and why;
- To examine the results of the survey alongside the results of the technical assessment to highlight any key issues or areas requiring further investigation.

This document reproduces the written submissions received to the survey. A summary of the survey submissions received online is also being published. In all cases, personal information has been removed.
